

From the Pastor's desk at Cross Lutheran Church-NALC,



"And he told this parable: "A man had a fig tree planted in his vineyard, and he came seeking fruit on it and found none. And he said to the vinedresser, 'Look, for three years now I have come seeking fruit on this fig tree, and I find none. Cut it down. Why should it use up the ground?' And he answered him, 'Sir, let it alone this year also, until I dig around it and put on manure. Then if it should bear fruit next year, well and good; but if not, you can cut it down." (Luke 13:6-9)

About 15 years ago, LuAnne and I planted three apple trees in our front yard. Each species of apple was different. Of the three bare root plants, the tallest and healthiest looking plant was planted in the front yard by the street. A few years later, we noticed that the tree started to lean as it continued to grow. Of the three trees, it continued to be the best looking and most promising. Even though it seemed to lean more and more each year, we decided to wait and see if it self-corrected.

Last year, this tree, "the apple of our eye," continued to bend over so much that if there were a bumper crop of apples in the future, the weight of its fruit could possibly uproot the tree and it would destroy itself. Besides that, it was apparent to all that passed by that there was something wrong with this tree. It was also difficult to mow around it, and its branches were so close to the ground on the one side that I would occasionally snag my hat when I worked around it. After talking about its future, we decided to call our son so he could bring his chainsaw over on his next trip to just cut it down. That seemed to be the quickest and easiest method for us deal with this tree that had become problematic and an eyesore.

As promised, our son came over with his truck and chainsaw ready to remove the tree, but before the work began, we walked around it and talked. He said, "It is a nice tree, except that it is leaning. If I drive a large post in the ground outside the root ball and put a strap on the trunk of the tree about here, I may be able to put enough gentle pressure on it to help the tree over time, to straighten itself." I knew that this was not going to happen overnight. If a lot of pressure was put on the tree trunk too quickly without being able to slowly adjust to this new tension, something would surely

break. Since we were soon heading back to Michigan, I asked our son if he was willing to watch over the tree and continue to adjust the strap a little bit over time to straighten the tree. He promised that he would.


Today, those who pass by can see that the tree is still there. And for the first time in many years, it is standing tall and growing upward. But sight unseen, the tree is building a more solid root structure underground in the areas where it was nonexistent. It continues each day to experience newer growth in areas that in the past couldn't compete with the opposite side. The overpowering roots that although continued to grow and provide a solid foundation, didn't allow the weaker side to thrive, and threatened their future existence.


There are many churches that are like this apple tree. They have a bright future for new growth, but instead of growing together in all areas, one side causes a noticeable imbalance. Yes, it provides a firm structure in one area by itself, but other areas may be neglected causing them to wither and die. A proper foundation is necessary to support all areas of ministry. Working together in Christ will produce new and continued growth. It will also produce the fruit of the Spirit. (Galatians 5:22) "And if a house is divided against itself, that house will not be able to stand." (Mark 3:25)

Our apple tree could have been quickly cut down and hauled away, or just left to destroy itself, but there was a third choice that required some diligent work and a time commitment. It required patience, love, and faithfulness. If this apple tree were yours to watch over and care for, what would you promise to do?

Warmer weather and a new season for growth is just around the corner!

"Everyone who comes to me and hears my words and does them, I will show you what he is like: he is like a man building a house, who dug deep and laid the foundation on the rock. And when a flood arose, the stream broke against that house and could not shake it, because it had been well built." (Luke 6:47-48)
