From the Pastor's desk at Cross Lutheran Church-NALC,

"Have I not commanded you? Be strong and courageous.

Do not be frightened, and do not be dismayed,
for the Lord your God is with you wherever you go." (Joshua 1:9)



How wonderful those words must have sounded to Joshua when he was commissioned to lead the Israelites into the Promised Land. "Do not be afraid."

How wonderful those words must have also sounded to others in the Bible that heard, "Do not be afraid." (There are approximately 70 instances in the NIV translation) Many were called by God to serve: Abraham, Jacob, Moses, the Israelites, Joshua, Gideon, Elijah, Jeremiah, Ezekiel, Joseph, Mary, Mary Magdalene, Zechariah, the Shepherds, Jesus' disciples, Paul, and John. And how wonderful

it is to have those same words proclaimed to us? If only we would believe them when we are feeling doubt and fear...

We work each day to be more in control of our happiness. When we have both feet firmly planted on the ground—we feel that we have the power to find our own peace. We love to feel safe and confident. But when we step outside of our safety zones, our comfort zones, our "that's the way we've always done it" zones, we realize our weaknesses, our vulnerability, our mortality. We lack confidence, we doubt, we fear. It becomes overwhelming. We can no longer comfortably carry the burdens, and our sinful, selfish lives leave us alone and afraid. Only God's words of promise give us our only strength and hope. How wonderful it is to hear God's promise when we go forward each day. "Be bold and courageous, do not be afraid, I will be with you wherever you go."

I have a picture in my church office that is a wonderful reminder of those words. It is a picture that I received at my 9th grade confirmation that shows a young man at the helm of a boat. His hands are on the ship's wheel at 9 o'clock and at 2 o'clock. The sky is dark and the clouds are billowing and rolling with the wind. The sea is churning and waves are coming over the side of the vessel.

If you look at the face of the young man, his eyes are looking straight ahead and his face is relaxed, yet focused on the view ahead. And standing behind this young man with His left hand on the young man's shoulder and His right hand outstretched with his finger pointing forward, is the artist's portrayal of Jesus

Christ. As you look at the expression on the young man's face, it begins to look more like the expression on Jesus' face. It projects a sense of peace, yet at the same time courage to go forward. These gifts can only come from God!

There is a well-known hymn, whose first verse vividly describes what we may encounter during our life's journey. Edward Hopper wrote "Jesus, Savior Pilot Me" with sailors in mind, but it speaks to all of us. It reminds us that God will lead and guide us, if we listen and follow His Word.

Jesus, Savior, pilot me, over life's tempestuous sea; Unknown waves before me roll, hiding rock and treach'rous shoal; Chart and compass come from thee. Jesus, Savior, pilot me.

How wonderful! God is our guide, our refuge, our calm in every storm.



What you need:

- 1 cup pearled barley
- ½ cup sundried tomatoes
- 1 Tbsp dry minced garlic
- · 1 Tbsp dry minced onion
- 1 veggie bouillon cube
- Glass pint jars with lids
- Cardstock
- Scissors
- Pen

What you do:

- In order, layer the first five ingredients into the jar.
- Trace the outline of the lid. onto cardstock. Cut out.
- On the card, write these directions: Remove wrapper from bouillon cube. Add contents of jar to saucepan. Add 4 cups water and a can of diced tomatoes. Bring to a boil over high heat, reduce to low. Simmer about 20 minutes, until barley is tender. Serve with parmesan cheese.
- Place the card atop the lid. Screw on the canning ring to keep it in place.



The meeting was called to order at 5:30 by Dick Koehler. David Faupel led with prayer.

Minutes:

A motion was made by Michelle W. to approve the agenda of the Thursday, June 9, 2022, meeting and seconded by Rebecca Y. Motion carried.

Agenda:

A motion was made by Rebecca Y. to approve the minutes of the Thursday, May 5, 2022, meeting. It was supported by Michelle and unanimously approved.

Guest: No guests Treasurer's Report:

School balance: \$90,209.59 CEA balance: \$4,591.57

Hot Lunch balance: \$3,183.08

A motion was made by Michelle and supported by Rebecca to approve the Treasurers' reports. It was approved.

CEA President's Report:

At their recent meeting, plans were made for events and fund raising for the 2022-23 school year. This is to help the parents be aware of upcoming events and fundraisers at an earlier date. Lindsey Stachowiack will be the new vice president for 2022-2023.

Principal's Report:

Projected enrollment for 2022-2023 is 68 students.

Calendar:

The school year calendar was presented. Michelle made a motion to accept the 2022-2023 calendar. It was seconded by Rebecca and the motion was carried.

Summer school will be taught by Sarah du Toit two days a week for 4 weeks. Her wages are paid by a State of Michigan grant.

Old Business:

Ideas for the use of the donation made to the school were tabled.

The refrigerator was replaced. We will discuss the sharing of costs with the Day Care.

Hot lunch costs will be raised to \$3.50 due to increased food costs. A motion was made by Michelle, seconded by Rebecca and passed unanimously.

There were no updates on the exterior building work, the storage shed, and evacuation procedures.



New Business:

Tuition assistance for the 2021-2022 year was \$1,278.50. A motion was made by Rebecca and seconded by Michelle to pay this amount. It was carried.

The band teacher's salary is paid by the Laker district. Cross is responsible for extra hours he works. The total we are responsible for is \$813.75. Michelle made a motion to pay this amount, it was seconded by Rebecca, and was carried.

Some summer purchases to be made that are paid for with a State of Michigan grant are projector updates, 10 new desks and chairs, and Chrome Books. Consumable materials will be paid from the annual funds.

A rack to place electronic devices in the storage room on will be purchased as well as some updating so there is continuous power to the computers at a cost of \$806.50. Rebecca made a motion to make these purchases, seconded by Michelle and unanimously passed.

Mrs. Eberly, the DK/K teacher, requested the purchase of Abeka Curriculum teacher additions at a one-time cost of \$424.50. Michelle made a motion to purchase these materials, it was seconded by Rebecca, and passed.

The following positions are to be posted: Kitchen Assistant; 3-8th grade support teacher to be paid with a grant; Art and PE shared time teacher.

There was discussion, and the board decided to send a letter to the Council President as a show of support for our teachers concerning their hard work, added students, and costs of living at this time.

The meeting was adjourned and closed with the Lord's Prayer at 6:58 p.m. The next meeting is **Thursday, August 4, 2022.**

From the Worship and Music Committee

As many of you know, the W&M Committee has been investigating how to maintain our pipe organ and to prepare it for use as we move forward into the future.

Our instrument was made by the Tellers Organ Company in 1964. The organ has served us well and has had two maintenance instances in all that time, aside from regular tunings. It is a historic instrument to this church and is highly valued in the tradition of our church.

The organ has now reached an age where a major overhaul is required consisting of several items of necessity. The console, the part you all see every Sunday where Beth sits, is worn out. The keyboards require frequent attention, and the internals no longer have parts available for repair. Many repairs have already been attempted with varying degrees of success by using seat-of-the-pants engineering. The organ itself, which lives in the loft behind the nave, needs reconditioned bellows, air supply repairs, and new actuator mechanisms for the shades which help control volume. There are also some additional minor repairs required. All of these issues are not abnormal considering the age of the organ and should be considered normal wear and tear.

The W&M Committee with technical guidance from Beth and Mike have been gathering information about the repair process as well as vendors that would be available to do the job. We have been keeping an eye on the direction of worship at cross and would like any changes to be compatible not only with traditional worship and hymn singing but new contemporary styles as well.

A short presentation has already been made to the council that outlined various options and vendors. We have now decided on a particular vendor that would suit our needs. The Evola Music Company and representative Lance Luce have been selected as the preferred vendor. They represent the Allen Organ Company based in Macungie, PA. They were chosen for many reasons some of which are: being local, two hours away on the north side of Bloomfield Hills; full-service company providing installation, service and parts; expertise of numerous installations in the area as well as world-wide; and finally, openness to the idea of a hybrid instrument.

A hybrid instrument is one in which the remodeling effort includes and uses the existing organ and supplements it with electronic voices and controls. Although there would be room in the organ to add some additional pipes (voices) it is cost prohibitive when compared with electronic voicing. Also, replacing the console is such a significant expense in and of itself, it only makes sense to make the organ as capable as possible. This would include at least the following: MIDI capability which allows the playing of additional voices on another instrument or by another instrument; a sequencer, should we lose an organist due to vacation or transition, to allow playing pre-recorded hymns through the organ; and better controls with a possible third keyboard to allow the playing of more expanded literature.

There is no timetable established for any of this at present. The scope of a project like this will require not only consideration of council but ultimately funding and approval by the entire congregation.

The step of selecting a vendor allows us to fine tune specifications and get accurate estimates that we can present to both council and congregation for consideration. It is likely that we will have specific information for you all by the fall time frame. We will keep you apprised of any developments. In the meantime, please give this some thought and bring any questions you may have to any of us on the W&M Committee. We are here to serve the congregation. We also feel that a strong music program with the resources to support it not only enhances our worship but also helps us make a joyful noise and is attractive to those visiting our space.
