From the Pastor's desk at Cross Lutheran Church-NALC,



The meeting was called to order by Church Council President, Michael LePage, at 7:03 p.m. Present: Nancy Heck, Gretchen Roestel, Krisie Fritz, Pastor Glenn S. Sokolowski, Nancy Schuette, Kent McKenzie, Corey Messing, and Steve Schulze. Absent: Norman Nelson. Guests: David Faupel and Sarah Brooks.

DEVOTIONS: Then Peter came up and said to [Jesus], "Lord how often will my brother sin against me, and I forgive him? As many as seven times?" (Matthew 18:21). Pastor read the weekly SOLA Devotion for Sunday, September 13, 2020.

AGENDA: Nancy Schuette made a motion to approve the Agenda as presented, seconded by Kent McKenzie. Motion carried.

<u>MINUTES</u>: Kent McKenzie made a motion to approve the July Minutes and Special Meeting Minutes, dated July 12, 2020 as presented, seconded by Gretchen Roestel. Motion carried.

OFFICER REPORTS:

Mike LePage, President gave his report as follows:

- Invoices need to be a paid for furnaces.
- Booms job completed, have invoice. \$13,685.00 was to be paid from the private bequest, check can be written to Cross Lutheran Church.

- Steve Schulze spoke to Booms and he will get the permits needed for the expansion area. Steve Schulze will call again to keep Booms moving on this project.
- A few things were changed in the sanctuary using rope, need to have an additional meeting with the ushers.

Steve Schulze made a motion to abide by mask wearing and to follow the State guidelines, seconded by Kent McKenzie. Motion carried unanimously.

- Clarification was needed regarding funerals and dinners. Pastor Glenn stated that he would work with families regarding masks and social distancing for weddings and funerals. Funeral dinners are on hold at this time.
- Ministries need to start meeting again. Need to social distance and wear masks.
- Back to School Sunday/Blessing of the Back Packs will be put on hold this year.
- Sunday School Wear Masks.
- Confirmation Pastor working on this, hoping to meet on Wednesdays at 6 p.m. (Confirmation will take place on Reformation Sunday in the future.)
- Operation Christmas Child may have enough to fill 80 boxes which could be filled by the students at Cross.
- NALC is looking for school and health kits.
- Cantata/Christmas Program will table for a month. (With Covid-19, may postpone for a year.)

Krisie Fritz, Secretary -Communications -None

Nancy Heck, Treasurer -Nancy gave her report as presented.

Motion was made by Nancy Schuette to approve the Treasurer's Report as presented, seconded by Krisie Fritz. Motion carried.

Discussion regarding balloon maturing on current Mortgage with Thumb Bank & Trust (current rate of 2.75%). Cross received 2 bids from Bay Port State Bank and Thumb Bank & Trust. Both banks quoted 2.50%, Closing Costs \$750.00 at Bay Port and \$350.00 at Thumb Bank & Trust.

Steve Schulze made a motion to accept Thumb Bank & Trust, Mortgage Rate of 2.5%, and loan fees in the amount of \$350.00, seconded by Corey Messing. Motion carried. President, Michael LePage and the Treasurer, Nancy Heck, will sign the documents on behalf of Cross Lutheran Church.

GUEST PRESENTATIONS/REQUESTS:

David Faupel gave his school report as follows:

- The classroom walls and carpeting projects were completed. Classrooms look great!
- We have 46 students enrolled for 2020-2021! We need to continue making short and long term plans to accommodate continued growth.
- The Shared Time Agreement between Cross Lutheran School and Lakers Schools is being continued this year in which Cross teachers receive some pay from Lakers for teaching non-core subjects (music, band, art, PE). Cross will receive a benefit of approximately \$43,000 from this arrangement this year.
- The church overflow will be used for band classes on Tuesdays, Wednesdays, and Thursdays from 8:45

 -11:15. The choir room will be used for piano classes on Mondays and Fridays from 10:00-11:15. In
 the case of a funeral, other arrangements will be made. If a church group would like to use these
 spaces at other times, we hope they do so (with approval from Pastor and coordination with the
 church office).
- Anyone wishing to visit Cross Lutheran School (including gym, kitchen, etc.) during the 2020-2021 school year will need to get approval ahead of time from school administration. Approved visitors may access the school through the Cross Lutheran Church Office entrance and will be required to sign in at the office and have their temperature taken. Visitors must then sign out and leave the building after their task has been completed. Masks will be required to be worn inside the building by visitors at all times.

Sarah Brooks gave her Early Childhood Center Report as follows:

- Sarah reported that they moved over to the Temporary Location in the Church.
- Grant money of \$31,000.00 has been paid to date.
- Sarah applied for the July grant, but wasn't sure if she would apply for the August grant.
- Haven't heard back on the \$20,000.00 grant.
- No benefits have been offered to Sarah's staff for having children in the day care. Asked if Cross could offer a discount to her staff.

Kent McKenzie made a Motion to give a benefit discount of \$15.00 a day and \$2.00 per hour for Latchkey for staff working with the Day Care Program.

ADVISOR'S REPORTS:

Pastor's Report: (9) Online services, (6) In-Person Worship Service, (2) Wedding Preparation classes, (1) Funeral Service, (1) Cemetery Inurnment service, (2) Worship and Music Committee Meetings, Total Knee Replacement (missed 3 Sundays in the pulpit), (1) Executive Council Zoom meeting, (1) new member installation, hosted school staff gathering, continued weekly local delivery of audio CDs and video DVDs of recorded Worship Services, continued phone calls and conversations.

Pastor Glenn also reported that the NALC National Convocation will be held every other year after 2021. NALC is asking each congregation to give \$200.00 per year to help with the NALC Mission District Dean's travel expenses, and is requesting that each congregation will give \$1300.00 the off years for the convocation for new NALC Church Mission starts.

School Board Report: Gretchen Roestel reported that the School Board appointed Kevin Trost as Vice-President. The School Board is working on filling the Treasurer position.

There will be no packing party. It is estimated that we have supplies on hand to fill about 75 boxes. Lorraine, Tonja and Kim will take an inventory of what we have.

Samaritan's Purse is offering several ways that people can continue to give to Operation Christmas Child this year. The best way to get involved is to pack a shoebox yourself. If this is not an option, OCC will pack a box for you. You can also build shoeboxes online. There will be more information coming about how the collection will take place at Cross this year. Watch the bulletin, newsletter and Facebook for more information.

We will find out if Bay Shore Camp will be a collection site again this year. We will also check with Mr. Faupel about having the Cross school children pack some boxes. We will also keep checking the Operation Christmas Child COVID-19 landing page for regular updates.
